

Camp Misquah Camper Covid-19 Guidelines 2023

These guidelines were developed by the Camp Misquah 2023 Camp Director with reference to the *Ontario Camps Association* 'Covid-19 Safety Guideline for Camps' and the *Association des Camps du Québec* 'Guide to Covid-19 Measure for Camps' (see links below).

Please note: These guidelines are subject to change as the OCA & ACQ recommendations change and summer approaches.

Exposures

- We recommend that campers limit exposures as much as possible for the days leading up to camp. Exposures = high-risk contact with those outside of their immediate household.

Isolation

- All campers travelling outside of Canada before camp must follow federal/provincial guidelines for isolation.

Rapid Antigen Testing

- As of right now, Rapid Antigent Testing will not be required this year. However, Camp Misquah reserved the right to make them mandatory before coming to camp if we feel the COVID-19 threat has increased as camp approaches.

Vaccinations

All campers must show proof that they are fully vaccinated (2 doses against Covid-19 at least 2 weeks before the start of the summer, unless exempt as per provincial guidelines.

Covid-19 Screening Assessment

- Campers will not have to complete a Covid-19 screening assessment on the first day of camp this year. However, Camp Misquah reserved the right to make them mandatory before coming to camp if we feel the COVID-19 threat has increased as camp approaches.
- Camp Misquah staff will screen each camper daily for any new symptoms and report this to the nurses/directory team. If the camper fails a Covid-19 screening at any point, an assessment will be completed by the nurses and a final decision will be made whether or not the camper will need to leave the site. Camp Misquah will not be completing any Covid-19 tests on-site this summer for campers.

Other Covid-19 Related Policies (distancing, masks, hand hygiene)

Campers will be expected to follow all Covid-19 related policies **to the best of their ability**. Camp Misquah staff will be available to offer reminders and make sure the Covid-19 guidelines are followed as best as possible. These policies include, but are not limited to:

- Campers will be encouraged to practice proper hand hygiene. Assistance and reminders will be offered.
- Mask wearing will not be mandatory at camp this summer. However, Camp Misquah reserved the right to make them mandatory before coming to camp if we feel the COVID-19 threat has increased as camp approaches.
